Potential Health Effects

Inhalation:

Short Term Exposure: Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

Long Term Exposure: No data for health effects associated with long term inhalation.

Skin Contact:

Short Term Exposure: Available data indicates that this product is not harmful. It should present no hazards in normal use. In addition product is unlikely to cause any discomfort in normal use.

The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

Section 5 - Fire Fighting Measures

Section 6 - Accidental Release Measures

Accidental release: This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, simply mop and clean up, putting waste into garbage or flush to sewer. It is good practice to wear rubber or PVC gloves when handling this product in the commercial setting. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services. Do not allow to contact with ingredients mentioned in Section 10 below.

Section 7 - Handling and Storage
