Inhalation:

Short Term Exposure: Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

The ASCC TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:



Section 6 - Accidental Release Measures

Accidental release: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. However, if you have any doubts consult the Australian Standard mentioned below (section 8). Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Can be slippery on floors, especially when wet. Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Conditions to Avoid: This product should be kept in a cool place, preferably below 30°C. Keep containers tightly closed. Containers should be kept dry. Keep containers and surrounding areas well ventilated. **Incompatibilities:** strong oxidising agents.

Fire Decomposition: Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Polymerisation: This product will not undergo polymerisation reactions.

Section 11 - Toxicological Information

Ingestion of aliphatic hydrocarbons has been reported to produce gastrointestinal irritation with pain, vomiting and diarrhoea. However, the effects vary from one type to another. This grade is selected for its low effects on human health and is unlikely to cause any significant health effects unless gross exposure occurs. Inhalation of aliphatic hydrocarbon vapours seems to show little toxicity.

Section 12 - Ecological Information

This product is biodegradable. It will not accumulate in the soil or water or cause long term problems. Biodegradation is expected to be the primary fate process for aliphatic hydrocarbons in soil and water. The rate and extent of biodegradation are dependent on the ambient temperature, the presence of a sufficient number of microorganisms capable of metabolizing the hydrocarbons and the concentration of white spirit in or on the soil or water.

Biodegradation of C_7 to C_{12} hydrocarbons is expected to be significant under environmental conditions favourable to microbial oxidation. Naturally occurring hydrocarbon-degrading microorganisms have been isolated from polluted soil and, to a lesser extent, non-polluted soil.

The low water solubility and moderate vapour pressure of white spirit (Stoddard solvent) suggest that volatilization and subsequent photo-oxidation are important processes for abiotic degradation in the atmosphere.

The octanol/water partition coefficient (log Pow) of white spirit (17% v/v aromatics) has been found to be 3.5 to 6.4. This indicates a moderate potential for bioaccumulation by organisms from water and a likelihood of partitioning to fat within organisms.

Section 13 - Disposal Considerations

Disposal: There are many pieces of legislation covering waste disposal and they differ in each state and territory, so each user must refer to laws operating in their area. In some areas, certain wastes must be tracked. The Hierarchy of Controls seems to be common - the user should investigate: Reduce, Reuse, and Recycle and only if all else fails should disposal be considered. Note that properties of a product may change in use, so that the following suggestions may not always be appropriate. The following may help you in properly addressing this matter for this product. This product may be recycled if unused, or if it has not been contaminated so as to make it unsuitable for its intended use.
