# Section 2 - Hazards Identification

### **Statement of Hazardous Nature**

### **Emergency Overview**

# **Potential Health Effects**

### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

Long Term Exposure: No data for health effects associated with long term inhalation.

### Skin Contact:

#### **Section 4 - First Aid Measures**

## **General Information:**

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor. **Skin Contact:** Gently brush away excess liquid. Irritation is unlikely. However, if irritation does occur, flush with

lukewarm, gently flowing water for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gentlybrush material from eyes. No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. ### **Section 6 - Accidental Release Measures**

# Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. # Section 10 - Stability and Reactivity
