The ASCC TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## SECTION 4 - FIRST AID MEASURES

## SECTION 5 - FIRE FIGHTING MEASURES

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products. In the event of a major spill, prevent spillage from entering drains or water courses and call emergency services.

## SECTION 7 - HANDLING AND STORAGE

### PRECAUTIONS FOR SAFE HANDLING:

Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. ### CONDITIONS FOR SAFE STORAGE, INCLUDING ANY INCOMPATIBILITIES

Make sure that containers of this product are kept tightly closed. Keep containers dry and away from water. Some liquid preparations settle or separate on standing and may require stirring before use. Check packaging - there may be further storage instructions on the label.

### OCCUPATIONAL EXPOSURE LIMITS

Exposure limits have not been established by ASCC for any of the significant ingredients in this product.

- Ventilation:** No special ventilation requirements are normally necessary for this product. However make sure that the work environment remains clean and that vapours and mists are minimised.

## SECTION 10 - STABILITY AND REACTIVITY

**REACTIVITY:** No significant decomposition products. This cosmetic product is stable under normal conditions of use, but, if exposed to extreme temperatures (above 50°C) for prolonged periods, may change texture and colour.

**CONDITIONS TO AVOID:** Keep containers tightly closed. Containers should be kept dry.

**INCOMPATIBLE MATERIALS:** Strong oxidising agents.

**HAZARDOUS DECOMPOSITION PRODUCTS:** Only small quantities of decomposition products are expected from this product at temperatures normally achieved in a fire.
